NOTIFICATION

The 21st October, 2020

No. S.O. 48/C.A.59/1988/St. 99, 100 and 102/Amd/2020.-In exercise of the powers conferred by section 99 and 102 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to formulate a proposal further to amend the Punjab Transport Scheme, 2018.

Notice is hereby given that any person may within a period of 30 days from the date of publication of the above said proposal in the Official Gazette, file objections as required under sub-section (1) of section 100 of the aforesaid Act, to the Principal Secretary to Government of Punjab, Department of Transport, Punjab Civil Secretariat-2, Sector 9, Chandigarh against the proposed Scheme given below and such objections shall be considered by the State Government in accordance with the provisions of sub-section (2) of section 100 *ibid.*, namely:-

DRAFT SCHEME

1. (i) The Scheme may be called the Punjab Transport (Amendment) Scheme, 2020.
(ii) It shall come into force on and with effect from the date of its publication in the Official Gazette.
2. In the Punjab Transport Scheme, 2018 (hereafter referred to as the said Scheme) for clause 4, the following shall be substituted, namely:-
"4. So as to curtail unhealthy competition among stage carriages that results in over-speeding, unauthorized stoppages and sudden braking causing discomfort to passengers on board and compromising road safety, a computerized time table shall be introduced which shall ensure equity, public interest organized and regulated movement of stage carriages. All the STUs and private operators holding stage carriage permits shall follow the same."

3. In the said Scheme, in clause No. 9, for item No. (iii), the following shall be substituted namely:-

"(iii) the operator furnishing an undertaking to comply with all the terms and provisions of the present Scheme except that prescribed in Clause 3E."
