**No. 3/4/2021-2T2/950** In exercise of the powers conferred by Section 3 of the Punjab Motor Vehicles Taxation Act, 1924 (Punjab Act No. 4 of 1924) (amended, 2021), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to levy the Green Tax at the following rates on the Motor Vehicles mentioned as under: -

Note : There shall not levy of Green Tax if the vehicle is operated by LPG, CNG, Battery or Solar Power.

The amount collected on account of Green tax shall be credited into the major head "0041- Taxes on Vehicles-00-102 Receipts under State Motor Vehicle Taxation Acts-06 Green Tax-00-00"

This notification will come into force with effect from 01.09.2024


