No. 8/1/2021-3T3(4T3)/ This is in continuation of Punjab Government Notification no 8/1/2021-3T3/719 dated 16.03.2023 vide which the route were formulated as per section 68 (3) (ca) of Chapter V of the Motor Vehicles Act, 1988 read with clause 3E of the Punjab Transport Scheme dated 22.02.2018 as modified on 04.06.2019, in order to regulate the operation of stage carriage(buses) having the minimum and maximum seating capacity 24 and 35 seats including driver and conductor respectively in the Rural Areas in the interest of travelling public.

Since the below mentioned formulated routes on re-survey/examination are not found to be conforming the conditions laid down by the Government for the grant of stage carriage permit for such stage carriages(buses),therefore, the same are hereby de-formulated on the ground as indicated against each:-
